

**Regulations participaton**  
**in Design talks Business Training | EcoDesign organized by PPNT Gdynia | Design Center**

**§1**

**General information**

1. These Rules and Regulations govern participation in Design talks Business Training | EcoDesign organized by the PPNT Gdynia | Design Centre, budget unit of the Gdynia Municipality, with its registered office in Gdynia, Al. Zwycięstwa 96/98, PSTP Gdynia – Design Centre, further referred to as the Organizer.
2. The aim of the event organized by the Organizer is to develop the skills of designing, transforming and implementing projects in the field of contemporary forms of design as well as to support, promote and develop creative sectors.

**§2**

**Rules of participation in event**

1. For event organized by PPNT Gdynia | Design Center is subject to registration.
2. The event is addressed to all people interested in the subject matter, including students, graduates, doctoral students, freelancers, entrepreneurs and people related to the creative sector.
3. Prior registration is required for participation in the event through the application form available at [www.centrumdesignu.gdynia.pl/en](http://www.centrumdesignu.gdynia.pl/en)
4. Following registration, the Participant shall receive a confirmation of being entered on the participant list or the reserve list – if the number of interested persons is greater than the number of available places.
5. In the event of a limited number of places, the Organizer reserves the right to select participants based on the submitted forms.
6. The selection of participants in the case of more applications than places will be based on the information and responses sent in the form, so that the workshop group has a similar level of knowledge and skills.
7. Participants will be informed about whether or not they qualify by a separate e-mail, which will be sent after the registration is closed and the submitted forms are assessed
8. Not later than a week ahead of the planned event, the Organizer shall ask persons entered on the list of Participants to confirm their attendance. Failure to obtain such confirmation may result in deleting the Participant from the list.
9. The Organizer reserves the right to reschedule the event without providing the grounds. Notification about changing the event date shall be sent by e-mail to the address provided by the Participant upon registration.
10. The Participant shall:
  - behaving in a manner that respects the principles of so-called Netiquette, i.e. no banning of profanity, no spamming in event chat and sending links unrelated to the event and its topic, no provocation of other participants and quarrels, no abuse of punctuation and capital letters, no flooding, i.e. sending the same messages in a short time interval, a ban on expressing views on the grounds of racism,

xenophobia or one that in any way attacks minority groups and offensive comments related to the subject of gender, gender identity, age, sexual orientation, disability, appearance, race, religion and those that could offend other event participants, follow instructions given by the Organizer and security staff.

11. The Organizer reserves the right to eject from the event any Participant acting in a manner that:
  - disrupts order and violates the generally approved rules of behaving in public spaces;
  - violates the principles of personal culture and disturbs other Participants of the event.
12. Participants shall transfer their copyrights, including the right to exercise derivative copyrights referred to in Articles 2 and 46 of the Copyright and Related Rights Act in all fields of use referred to in Article 50 of the 1994 Copyright and Related Rights Act, with respect to works created during the Event to the Organizer.
13. Participants acknowledge that copyrights to any and all modifications and adaptations (including the right to use and dispose of them) shall be the sole property of the Organizer in all fields of use referred to in Article 50 of the 1994 Copyright and Related Rights Act.
14. At the request of the Organizer, the transfer of rights described in paragraph 12, 13 and 15 and 16 the Participant will confirm in writing (agreement). Until written confirmation, the Organizer has the right to use the above-mentioned rights on the terms applicable to the owner.
15. The Organizer shall have the right to retain works, working materials, 3D files, photographs and text files created during the Event, irrespective of the form in which they are recorded; their ownership title shall be transferred to the Organizer free of charge after the end of the event.
16. In the event of third parties approaching the Organizer with claims concerning violation of copyrights or personality rights of third parties related to works created in the course of event, the Participant shall bear all costs and pay compensation concerning the claims of such parties.
17. Without prejudice to Organizer's rights, the Participant may publicly refer to and present works created during the event without limitations concerning time or territory.

### §3

#### Resignation

1. Following registration and payment of the fee, there is no possibility to resign from participating in the event.
2. Participants have the right to transfer their tickets to others, having informed the Organizer about it at [e.chudecka@ppnt.gdynia.pl](mailto:e.chudecka@ppnt.gdynia.pl) not later than a week before the planned event.

### §4

#### Liability and compensation

1. The Organizer does not insure participants of event and shall not be liable for any losses, such as the loss, defect or damage to equipment, clothes or other objects belonging to the Participant.
2. The Participant shall be liable for any losses incurred by the Organizer as a result of the Participant's negligence. In the event of detecting losses, the Organizer shall draw up the

relevant documentation including a repair cost estimate – a copy of which shall be sent to the Participant's address – and perform the repair in line with said estimate. The Participant shall cover the full cost of removing the damages within 14 days from receipt of the debit note.

## §5

### Final provisions

1. The Organizer shall not be liable for force majeure event. Force majeure shall mean, in particular, weather conditions, failures or disruptions in electricity supply units.
